NOTICE INVITING TENDER NO. 16 OF 2024-25 Dated 09.09.2024

Plassey College invites sealed quotations from concerned agencies for the work of "Finishing Work of Open Stage Phase-II" at the college campus. Willing agencies are asked to offer their rates on the estimated amount of Rs. 77639.00 (inclusive of all taxes) into the "Tender Box" at Plassey College Office/ Security Guard Room only during office-working hours within 24.09.2024 (Tuesday) up to 2:00 p.m.


Sealed Tenders are hereby invited by the undersigned for the following work from eligible agencies as per particulars given below:

- 1) Name of work : Finishing Work of Open Stage Phase- II at Plassey College, Mira Bazar, P.O.-Plassey, Dist-Nadia
- 2) Name of the Concerned Office : Plassey College, P.O.-Plassey, Dist - Nadia, Pin- 741156
- 3) Estimate for the Project : Rs. 77639.00
- 4) Time of Completion of work : 30 days from the date of acceptance of Work Order
- 5) Contractors eligible to submit tenders : Bona-fide contractors & NGOs having GSTIN, PAN and I. Tax return certificate (A.Y. 20-21,21-22, 22-23, 23-24)
- 6) Place for submission of Tender document : Tender Box at College Office
- 7) Date of Publication of NIT : 09.09.2024, 11.00 a.m.
- 8) Last date & time limit for submission of Tender : 24.09.2024, 02:00 p.m.
- 9) Date & time for opening of tender : 24.09.2024, 02:30 p.m.
- 10) Validity of the Tender : The offer will remain valid for acceptance for 120 days from the date of receipt of tender
- 11) Conditional tender will be liable for rejection.
- 12) No Ad-Interim Payment /mobilization advance/ secured advance will be allowed.
- 13) Interested agencies are required to quote the rate in figure as well as in words (inclusive of all taxes)
- 14) Contractors shall have to comply with the provisions of (a) the contract Labour (Regulation Abolition)-Act, 1970 (b) Apprentice Act 1961 and (c) Minimum Wages Act, 1948 or the modification there or any other laws relating thereto and the rules and order issued there under from time to time.
- 15) The payment will be made in only after the completion of entire project and to the satisfaction of the college construction committee. Contractors are requested to quote their rates accordingly. The payment shall be made vide online transfer or account payee cheque.
- 16) The interested agencies will have to provide self-attested photocopies of PAN Card, latest Income Tax return, latest Professional Tax Clearance Certificate, GSTIN Certificate which will be valid up to the date of opening of the tender papers and other Credential Documents (within last 5(five) years from the last date of submission of tender documents) along with the Tender Paper.

- 17) Registered Labour Co-Operative Societies Ltd. will have to provide self-attested photocopies of current Audit Report, No Objection Certificate in support of their registration, Bye-laws, PAN Card, latest Income Tax Clearance Certificate, GSTIN Certificate, other Credential document (not less than 40% of the estimated amount in a single job and other documents for having experience of executing similar nature of work within last 5(five) years from the Last date of submission of tender papers).
- 18) Representation in Tender in connection with tender submitted by Co-Operative Societies:- The Chairman and the Secretary or three directors including either the Chairman or the Secretary shall execute and sign all deeds, documents, tender papers as per act of the Bye-Laws of the Co-Operative Societies, failing which the tender will be liable for rejection. The copy of last Audit Report (full) including copy of the minutes of last A.G.M has to be submitted along with application for verification of the authority.
- 19) In case of partnership firm, the interested agencies shall produce authentic document in respect of firm registration obtained from the Registrar of firms, West Bengal pursuant to the Indian Partnership Act – 1932 (Act IX of 1932) along with application (Deed made by Notary will be allowed).
- 20) No credential will be considered unless it is supported by payment certificate, work order and completion certificate mentioning the date of completion issued by the competent authority.
- 21) No person will be allowed to quote rate on the basis of Legal Power of Attorney conferred to him by the Firm/ Agency except in circumstances where necessary Govt. approval has been obtained.
- 22) The college authority shall be at liberty to take such legal action or actions as they deem fit and proper, in the event the agencies' submitted documents and credentials are found false and fake.
- 23) Incurred Income tax, GST and labour CESS shall be deposited by the agency itself under their respective registration numbers and its related certificate/challans (photocopy) shall be submitted to the undersigned as per Govt. norms.
- 24) The tender for the works shall remain open for acceptance for a period of 120 days from the date of N.I.T. If any agency withdraws his/her tender before the cited period or before the date of issue of work order/ letter of acceptance, whichever is earlier, or make any modification in the terms and condition of the tender which are not acceptable to the college authority, then the college authority shall, without prejudice to any other right or remedy, be at liberty to forfeit the entire earnest money. Further, the agency shall not be allowed to submit any tender in this Department for a minimum period of one year.
- 25) Earnest money is to be deposited in shape of a demand draft in favour of Principal, Plassey College payable at Plassey.
- 26) No material will be supplied to the agency by the college.

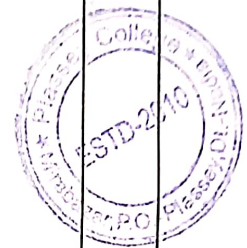
