

- 11) All products must be sealed properly with duly verified serial key number at the time of installation. All of the items will be scrutinized by the college authority before installation work. No faulty, duplicate or damaged items will be entertained. If any of the installed products is found to be reused or tampered material, in subsequent stages, the college authority has the full right to initiate legal procedures against the agency.

- 11) The interested agencies will have to provide self-attested photocopies of PAN Card, latest Income Tax return, latest Professional Tax Clearance Certificate, GSTIN Certificate which will be valid up to the date of opening of the tender papers and other Credential Documents (within last 5(five) years from the last date of submission of tender documents) along with the Tender Paper.
- 12) Representation in Tender in connection with tender submitted by Co-Operative Societies:- The Chairman and the Secretary or three directors including either the Chairman or the Secretary shall execute and sign all deeds, documents, tender papers as per act of the Bye-Laws of the Co-Operative Societies, failing which the tender will be liable for rejection. The copy of last Audit Report (full) including copy of the minutes of last A.G.M has to be submitted along with application for verification of the authority.
- 13) In case of partnership firm, the interested agencies shall produce authentic document in respect of firm registration obtained from the Registrar of firms, West Bengal pursuant to the Indian Partnership Act – 1932 (Act IX of 1932) along with application (Deed made by Notary will be allowed).
- 14) No credential will be considered unless it is supported by payment certificate, work order and completion certificate mentioning the date of completion issued by the competent authority.
- 15) No person will be allowed to quote rate on the basis of Legal Power of Attorney conferred to him by the Firm/ Agency except in circumstances where necessary Govt. approval has been obtained.
- 16) The college authority shall be at liberty to take such legal action or actions as they deem fit and proper, in the event the agencies' submitted documents and credentials are found false and fake.
- 17) Incurred Income tax, GST and labour CESS shall be deposited by the agency itself under their respective registration numbers and its related certificate/challans (photocopy) shall be submitted to the undersigned as per Govt. norms.
